

# Privacy policy

## General

Fuji Europe Africa is responsible for the processing of personal data as shown in this privacy statement.

## Personal data that we process

Fuji Europe Africa processes your personal data when you use our services and/or when you provide it to us yourself.

Below is an overview of the personal data we process:

- First and last name
- Email address
- IP address
- Other personal data that you actively provide by, for example, applying for a job, via correspondence and by telephone
- Location details
- Details about your activity on our website
- Data about your surfing behaviour across different websites (for example because this company is part of an ad network)

## Particular and/or sensitive personal data that we process

Our website and/or service does not intend to collect data about website visitors who are younger than 16 years old, unless they have permission from their parents or guardians. However, we cannot check if a visitor is older than 16. We encourage parents to be involved in the online activities of their children, in order to prevent data about children being collected without parental consent. ## For what purposes and on what basis we process personal data

Fuji Europe Africa processes your personal data for the following purposes:

- To send our newsletter and/or advertising brochure
- To call you or email you if this is necessary to carry out our services
- To inform you about changes to our services and products
- To provide you with the possibility to create an account
- To deliver goods and services to you
- Fuji Europe Africa analyses your behaviour on the website in order to improve the website and to tailor the range of products and services to your preferences.

- Fuji Europe Africa monitors your surfing behaviour on various websites with which we tailor our products and services to your needs.

Fuji Europe Africa processes your personal data on the basis of one of the following principles:

- Permission
- Agreement
- Legitimate interest

## **How long we store personal data**

Fuji Europe Africa does not store your personal data longer than is strictly necessary to achieve the purposes for which your data is collected.

## **Sharing personal data with third parties**

Fuji Europe Africa does not sell your information to third parties and only provides your information if it is necessary for the execution of our agreement with you or to comply with a legal obligation. With companies that process your data on our assignment, we conclude a processor agreement to ensure the same level of security and confidentiality of your data. Fuji Europe Africa remains responsible for processing these operations.

## **Cookies or similar techniques that we use**

Fuji Europe Africa only uses technical and functional cookies. And analytical cookies that do not infringe your privacy. A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. The cookies we use are necessary for the technical operation of the website and your ease of use. They ensure that the website works properly and remember, for example, your preferences. With this, we can also optimise our website. You can opt out of cookies by setting your internet browser so that it does not store cookies anymore. In addition, you can also delete all previously saved information via the settings of your browser.

## **Modify or delete data**

You have the right to correct or delete your personal data. In addition, you have the right to withdraw your consent to data processing or object to the processing of your personal data by Fuji Europe Africa, and you have the right to data portability. This means that you can submit a request to us to send the personal information we have in your computer file to you or another organisation named by you.

In order to ensure that the request for correction or removal has been made by you, we ask you to send a copy of your proof of identity with the request. Make your photo black in this copy. This is to protect your privacy. We will respond to your request as quickly as possible, but within four weeks.
